Dear Dr. Miyashiro:

Congratulations, all water samples collected at the schools in District have come back ND (Not Detected). Five samples were tested. According to State regulations, the laboratory will report the results to the Division of Drinking Water (DDW).

Per the DDW: All initial sample locations with a test result of 15 ppb (parts per billion) have lead levels less than the Action Level, the location requires further testing is needed.

We have also provided a copy of the laboratory results as an attachment to this email. Our Municipal Water District's Water Quality Specialist, Joe Guzzetta, is available for the following schools.

- Blossom Valley Elementary School
- Crest Elementary School
- Los Coches Creek Middle School
- Rios Elementary School

With the results being below the action level of 15 ppb, the results are being shared with the School District or Padre Dam, and the Lead Testing in School District.

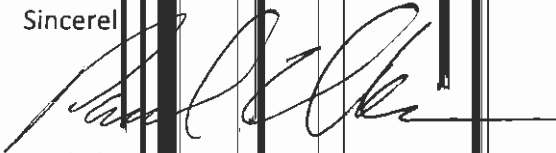
